**APPROVE AGENDA** – Supervisor Simons, supported by Treasurer Beaudua, moved to approve the agenda after removing, New Business 3 - Purchase DPW Truck and 4 - Hire Sewer Plant Operator, Matthew Willemsen. Carried.

**APPROVE MINUTES** – Treasurer Beaudua, supported by Trustee Patsalis, moved to approve the minutes of May 2, 2016. Carried.
